## Site Plan and Sign Detail Requirements for Sign Permit Applications

---

### Site Plan Requirements

- The site plan must be prepared to scale and provide all required information as required under Section 22 & 25.03 of the Orange Township Zoning Resolution.
  - \* *Site plans which are incomplete and/or not drawn to scale will not be accepted.*
- North arrow and appropriate scale (i.e. 1 inch = 30 feet)
- Setback distance of sign from property line and/or street right-of-way boundary
- The exact location of the proposed sign on the property/building
- All easements and above/below ground utilities, when applicable
- Regulatory floodplain (Floodway and Floodway Fringe) and riparian setback boundaries, when applicable
- Any other information with regard to the lot or neighboring lots which may be necessary to determine and provide for the enforcement of the Orange Township Zoning Resolution
- Two (2) copies - minimum size of 8.5"x11" paper, maximum size of 11"x17" paper *\*Larger size copies are acceptable in addition to the min./max. sizes required*

### Sign Detail Requirements

- The sign details must be prepared to scale and provide all required information as required under Section 22 & 25.03 of the Orange Township Zoning Resolution.
  - \* *Sign details which are incomplete and/or not drawn to scale will not be accepted.*
- Sign diagram and schematics, including dimensions, cross-sections and mounting
- Building elevations and/or architectural renderings indicating location of sign
  - \* Street frontage to calculate aggregate sign area
- Color renderings
- Sign key when applicable (i.e multiple signs)
- Two (2) copies - minimum size of 8.5"x11" paper, maximum size of 11"x17" paper *\*Larger size copies are acceptable in addition to the min./max. sizes required*
