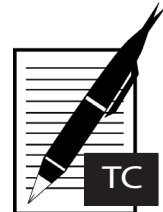

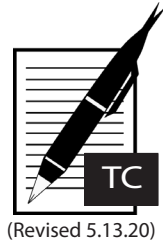

\*Please note that this Certificate shall remain valid for a period not to exceed six (6) months during alterations or partial occupancy of a building pending its completion as provided for by SECTION 25.06 – TEMPORARY CERTIFICATE OF COMPLIANCE of the Orange Township Zoning Resolution.

Furthermore, a permanent Certificate of Compliance shall be filed as required under SECTION 25.05 – CERTIFICATE OF COMPLIANCE: It shall be unlawful to use or occupy or permit the use or occupancy of any building or premises, or both, or part thereof hereafter created, erected, changed, converted or wholly or partly altered or enlarged in its use or structure until a zoning Certificate of Compliance shall have been issued therefore by the zoning inspector stating that the proposed use of the building or land conforms to the requirements of the Orange Township Zoning Resolution.
