Notice is hereby given that the Orange Township Board of Trustees will hold a public hearing on Wednesday, May 19, 2021 at 6:00 p.m. to consider the following application:

**Zoning Application #ZON-21-01, North Farms Development LLC.** Requesting to rezone one (1) parcel totaling 24.019 +/- acres from a Single Family Planned Residential (SFPRD) District to a Multi-Family Planned Residential (MFPRD) District.
